### PAPER SUBMISSION GUIDELINES

- DATE OF SUBMISSION OF PAPERS- ON THE BASIS OF HEAVY DEMAND FROM IEA FAMILY. THE LAST DATE TO SUBMIT THE PAPER IS EXTENDED UP TO OCTOBER 20.2020 . Papers received after the last date will not be (A) considered for publication in the Special issue of the Journal. Members can however be allowed to present their papers received after the due date only with the permission of the Chair. Plagiarism rules will be applied to all submissions. विशेष : आप अपने गणवत्तापर्ण शोध पत्र हिन्दी में भी उपलब्ध करा सकते है।
- (B) SIZE OF PAPER AND NUMBER OF COPIES-The paper should be in about 3000 words typed in Times New Roman font 12 (For English) Kurti Dev font 14 (For Hindi) in 1.5 space, with an abstract of 500 words. Papers without

abstracts will not be considered for publication. The title page should remain separate from the manuscript throughout facilitating double blind review. The manuscript should not contain any identity of the author. Articles should be typed in MS-WORD only. Research Papers on other formats, like PDF will not be considered. Kindly mention your date of birth in your forwarding letter for the easy separation of papers for selecting awards. The papers may be mailed to jeasecretary@rediffmail.com as per instructions or uploaded through IEA website www.indianeconomicassociation.in. While submitting the papers either through provided email or provided website, authors have to keep in mind the following points. The title page should contain-

- The manuscript title. a)
- b) All authors' names and affiliations
- c) Contributors of research papers are required to mention their Email ID, Phone / Mobile Number and address with PIN code along with their names and age in their covering letter. These are essential for co-authors also. This information is mandatory. It will help the editorial board to communicate to the contributors in an efficient manner. Identify which authors will present and/or attend, to the best of your knowledge as of the date of submission;
- c) The paper contributors, including co-authors, need to also mention in their forwarding letters their Membership Number. This is not compulsory. The membership status may be checked at our side.
- New applicants must mention "membership applied for" (along with the category of membership annual or life) in the forwarding letter. Papers without membership numbers of authors and co-authors will not be considered d) About Submission of Paper:
- The manuscript should be in English and checked for grammar and language errors. a)
- All contributors included in your paper should properly acknowledge with referencing and citations and the accepted style of referencing. b)
- c) Papers will be selected on the double-blind peer-reviewing process which will ensure that you receive developmental feedback on your paper. If the reviewers suggest advanced revisions, authors will be provided more time to revise the manuscript. In such a scenario, the publication of the manuscript will be pushed to the abstract form.
- d) Tables, figures, and images should be properly named and of good guality
- Respond to the call for reviewers to which you will proceed following completion of your submission/s. e)
- f) Confirm that you have not submitted more than 2 submissions on which you are the lead author.
- g) Identify up to three content area, keywords and one methodological keyword.
- ĥ) Confirm that you will present at the time, date, and format scheduled by IEA.
