Election Schedule & Election Guidelines

(A) Nomination

1. The candidate must download form [Form A & B] annexed with Election Notification from IEA website www.indianeconomicassociation.in
2. Downloaded nomination form [FORM A] after completion. The candidate will submit his/her nomination form in PDF format on email address electionofficeriea2020@gmail.com of Election Officer.
3. The contestant must give his/her self-declaration in Form 'B' and attach his/her academic bio-data not less than 150 words in PDF format submit to Election Officer's email address electionofficeriea2020@gmail.com
4. Proposer and seconder will also send Form-C in PDF format to Election officer through email electionofficeriea2020@gmail.com
5. Last date for filling nomination form is 06/06/2020 up to 03:00 PM.
6. It will be compulsory to send hard copy of nomination form [Form A&B] to Election Officer's postal address by speed post/courier.
7. List of nominations of candidates will be posted on 06/06/2020 time 06:00 PM upon website.

(B) Withdrawal & Objection

1. A candidate may submit his/her withdrawal form [Form D] in PDF format to Election Officer till 10/06/2020 on email electionofficeriea2020@gmail.com
2. Any objection upon nomination form will be submitted in Form 'E' to Election Officer in PDF format on email address electionofficeriea2020@gmail.com up to 08/06/2020 time 06:00PM.
3. Valid objection/s will be heard by Election Officer on 09/06/2020 and in this regard all the information will be send to objector and candidate through email.
4. Incomplete, overwriting, unsigned, blurred photograph, without Academic Bio Data shall be the grounds of cancellation.
5. Final list of valid candidates will be posted on the website www.indianeconomicassociation.in on 11/06/2020 after objection and withdrawal.

(C) Voting, Counting & Results

1. In the event of voting, election will be held on 15/06/2020 during 09:00AM to 03:00PM through E-vote. In this regard, all information will be posted on website at that time.
2. After completion of e-voting, e-counting will be started at 04:00 PM on 15/06/2020 till the declaration of result.
3. E-counting will be held at Aligarh.
4. Secrecy of vote must be maintained, if it comes to knowledge of Election Officer that such member disclose his/her vote secrecy, in that condition his/her vote will be declared nullified.
5. A candidate or his/her representative dully authorized [Form F], may be presented at the time of E-counting.
6. List of Members of Indian Economic Association is posted on website.
7. President will be elected for one (1) year and Vice President, Secretary, Treasurer and 33 EC Members will be elected for three [3] years.

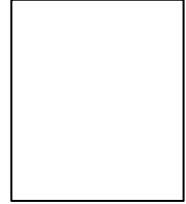

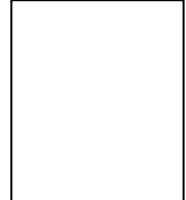
