Day 1: Monday, December 27, 2021

11:00 a.m. – 1:30 p.m.

Inaugural Session (Bappa Rawal Sabhaghar)

The inaugural ceremony of the 104th Annual Conference of The Indian Economic Association Hosted by Mohanlal Sukhadia University, Udaipur, Rajasthan on "Bharat Centric Approach to Economic Development: Post COVID Lessons" was held on December 27, 2021, in hybrid mode. At the outset, the guests were given the guard of honour by the cadets of Scout and Guide of all wings of MLS University. A welcome song was presented by the students of the Music Department. The session was chaired by Prof. Amarika Singh, the Hon'ble Vice-Chancellor of MLSU, Prof. Ghanshyam N Singh, Hon'ble President IEA and Prof. G.S. Rathore, Dean University College of Science. The special guests who graced the occasion with their presences were Prof. Shree Prakash, Senior Professor of Economics, Noida, and Hon'ble Chancellor Mr. Vivek Singh, Arni University, Kangra, HP.

The ceremony commenced with the *Kulgeet* of the University and *Saraswati Vandana*, followed by the recitation of the preamble of the Constitution and fundamental rights and duties by the Hon'ble Vice-Chancellor Prof. America Singh Sir. He expressed his pleasure in holding this significant academic event at Mohanlal Sukhadia University and in hosting delegates from all parts of the country and abroad. He expected that the deliberations in this conference will come up with some concrete suggestions to deal with the issues of poverty and the issues emerging due to global warming and climate change and Covid 19. He conveyed his best wishes for the success of this event.

Thereafter the felicitation of guests took place. Prof. Hanuman Prasad, the local organizing secretary of the conference, formally extended a warm welcome to all the dignitaries presented on the dais, guests and participants from various parts of the country, colleagues and students. He mentioned the significance of the conference and its aims about bringing together a core group of economists from all over India to fight against COVID-19 and to figure out possible

solutions to combat the epidemic. He also highlighted the achievements of the University since its inception and elaborated on the extension activities the University did during the pandemic time and social activities done in the tribal villages adopted by it.

Prof. D. K. Asthana, Secretary, IEA briefed about IEA and also about the importance of the topic of the conference. He said that IEA is the second oldest association in India and working since 1917. He motivated everyone to actively participate in the conference to get benefited. In his address, Prof. A. K. Tomar, Program Coordinator, acknowledged the efforts of the Vice-Chancellor, faculty members, scholars and students of the University to organize the 104th IEA Conference. He described three main themes, namely Global warming and climate change, poverty alleviation through the digital application, COVID-19 and the Indian economy and 4 sub-themes four sub-themes as agricultural technology and tribal economy, self-reliant economy, national education policy, the global and local digital revolution and Indian of the conference.

The Key Note Speaker for the inaugural session was Prof. A. P. Pandey, Former Vice-Chancellor of Manipur University and Former Director of National Small Industries Corporation. He discussed the impacts of Covid 19 and emphasised developing small scale industries and regaining the geospatial identities of local businesses as it was attached earlier and promoting our indigenous and ayurvedic methods of treatments for good mental as well as physical health.

Mr. Vivek Singh, the Vice-Chancellor of Arni University, told in his address that IEA is playing an important contribution to the Indian economy through research activities. After Corona, we are facing many economic problems and bodies like IEA can find solutions through research

Prof. Shree Prakash was conferred with *Atal Bihari Vajpayee* Award. Dr. Indu Varshaney, The treasurer of IEA read the citation of the Honour. Prof. Shree Prakash said in his speech that we have to rise above mental slavery and disseminate our research in the Indian languages. He recalled the contribution of Prof. H. S. Javenes, who established IEA and its Journal in 1914, and P. Brahamananda, who was the editor of The Journal of IEA for a long time, Prof. P.N. Mathur and Prof. Jagdish Bhagwati and suggested to institute the memorial lecture in the name of theses economists in next IEA conference. He also suggested to He said people have four types of ignorance and awareness of ignorance is the beginning of the knowledge so we should identify it and overcome it to be enlightened with the knowledge. With the example of pricing theories he tried to elaborate that we should try to explore knowledge and update it instead of being stuck to the acquired traditional knowledge.

IEA President Prof. Ghanshyam Singh told in his statement that IEA is doing historical work. In the last few decades, all the people of the organization have worked with courage even in this challenging time.

Prof. G.S. Rathore, Dean of the University College of Science, also welcomed all the guests and participants on behalf of the University and convey his best wishes for the success of the conference.



1:30 p.m. – 02:15 p.m. Plenary Session I -(Bappa Rawal Sabhaghar)

Theme I Global Warming and Climate Change

Just after the inaugural ceremony, the first plenary session on "Global Warming and Climate Change" commenced. The session was chaired by Prof. (Retd.) Ganesh Kawadia, Former Dean, School of Economics, DAVV, Indore and Prof. Halima S. Rizvi, Head Dept. of Economics; Jamia Millia Islamia, New Delhi, co-chaired the Session. Prof. (Retd.) H.S. Sharma, the Senior Geographer and Prof. Alpana Kateja, Professor of Economics both from the University of Rajasthan were the speakers (online) of the session. Whereas Prof. Sharma spoke on the issue more from an environmental perspective Prof. Kateja elaborated on the economic perspective of the same.

Prof. Sharma pointed out that the issue of climate change and global warming is a great buzz. It has been proved that the problem is becoming serious due to human activities. He also discussed the impact of climate change on India and Rajasthan. He elaborated that 26 districts of Rajasthan are under threat of climate change and the trend of extreme weather is turning from Churu to Sikar and Dausa. Prof Alpana Kateja in her speech mentioned that natural hazards cause a lot of harm. Some are quantifiable but mental and emotional losses are not measurable. Future research should focus o these losses too. She emphasized that three Rs-'Reduce, Reuse, Recycle' should be given due consideration and old or indigenous methods of living should be followed.

The chair of the session Prof. Ganesh Kawadia, Former Dean, School of Economics, DAVV, concluded the session with the suggestion that for sustainable development the cost of production should be measured not only in economic terms but in the terms of ecological footprints and instead of thinking 'Ek ke karne se kya hota hai" we should adopt the approach of "Ek-ek yani her ek ke karne se hota hai". Prof. Halima S. Rizvi explained the importance of data sources for environmental research and give some suggestions to improve the research in this field.



03:00 p.m. – 03:50 p.m.

Plenary Session II–(Bappa Rawal Sabhaghar)

Theme II Poverty Alleviation through Digital Applications

Post lunch on the first day two plenary sessions were held. The session on "Poverty Alleviation through Digitalisation" was chaired By Prof. (Retd.) M.K. Gadholia, Former Vice-Chancellor SKD University Hanumangarh and Co-Chair of the session was Dr D. K. Asthana, General Secretary IEA. The Key Speakers on the Theme were Prof. Seema Jalan, Head Dept of Geography and BoM member, MLSU and Prof. Syed Afzal Murtaza Rizvi, former Head of Computer Science Department, Jamia Millia Islamia, New Delhi. Prof. Seema Jhalan emphasized the multidimensional concept of poverty and suggested that it can be alleviated

with a multidimensional approach only. She also explained the role of technology especially geospatial technology in identifying the poor and helping them.

Prof. Rizvi suggested that if we produce human resources by imparting knowledge and skills and creating employability instead of producing just degree holders then poverty can be alleviated and for this transformational approach instead of a transactional approach should be adopted.

Prof. Ghadolia concluded that poverty is a complex phenomenon and cannot be alleviated in one go. Digitalization has entered every sphere of life. This new phenomenon can help in overcoming the old phenomena of poverty by providing access to services to the poor through it. It can help in good governance.





03:00 p.m. – 03:50 p.m. Plenary Session III (Meeting Room)

Theme III Covid-19 And Indian Economy

The third Plenary session on the theme "Covid 19 and Indian Economy" was chaired by Dr. R. K. Bhatnagar, Retired IAS officer and co-chaired by Prof. Madhurima Lall, Department of Applied Economics, University of Lucknow. The key speakers of the session were Prof. (Retd.) Nar Singh, Department of Applied Economics, University of Lucknow, Prof. Halima S. Rizvi, Head of the Department of Economics; Jamia Millia Islamia, New Delhi, Prof. (Retd.) Manmohan Krishna (online), Department of Economics, Allahabad and Prof. (Retd.) Debesh Bhowmik (online), Lincon College, Malaysia.

Prof. Nar Singh focused on industrialization and entrepreneurship for development in India especially promoting the private sector in UP. The second key speaker Prof. Halima S. Rizvi described Covid 19 situation as the conflict between life and livelihood. India emerged as a new strong country supporting others in providing vaccination to other countries. She also said based on her research that women suffered more from all perspectives due to Covid-19.

The third speaker of the session, Prof. Manmohan Krishna, estimated a 70000 billion rupees loss of GDP in 6 years due to Covid 19 and the growth of capital formation and consumption declined. Poultry and Floriculture were the main bearers in the agriculture sector. He also

explained the boost in Sensex and stock market activity and inflation due to expansionary monetary policy.

Prof. Bhowmik discussed various types or designs of digital currency and suggested if RBI would be able to design CVDC with the interest rate, it will be revolutionary. The digitalisation of the currency will reduce the transaction cost.

Day 2: Tuesday, December 28, 2021

10:00 a.m. – 10:50 a.m. Prof. P.R. Brahma Nanda Memorial Lecture (Bappa Rawal Sabhaghar)

Prof. Brahmananda Memorial Lecture delivered by Prof. D. M. Diwakar, Honorary Director & Professor, Development Research Institute, Patna on the topic "Growth and Inequality in India" in the gracious presence of the IEA President. The session was chaired by Prof. Alpana Kateja (online), Department of Economics, University of Rajasthan, Jaipur and co-chaired by Dr. A.K. Tomar, Programme Coordinator IEA. Prof. Diwakar initially explained the meaning

of the preamble of Indian in the context of the present scenario of Indian Economy. He mentioned that solutions to inequality can be found in critical economics. He emphasised justice, liberty, equality and fraternity. Further, he added the meaning of justice in social economics and politics, liberty in expression, equality in opportunities and fraternity to assure dignity. He majorly emphasized the fact that no religion permits the suffering of others.

In concluding remarks he said that inequality is not the result of economic growth and technological change but ideology and politics. Therefore pro-poor ideology and politics are the need of the hour to change structure, ideology and political institutions.





11:00 a.m. - 12:30 p.m.

Panel Discussion II

Topic – Atmanirbharta(Self-Dependence) - (Bappa Rawal Sabhaghar)

The session started with key speaker Prof. Prahlad Kumar's speech (online) where he emphasized the *Bharat-centric* approach to making *Bharat Atmanirbhar*. He said in around last 20 years Indian economy has grown in many vibrant areas and not only sustained but incarnated as a separate identity at the world level. But the economy has faced some major issues in the last one and a half years due to Covid-19. The best way to come out of this situation is to become self-reliant. Digitalization has helped a lot in this prospect. In a nation like India, all these things are difficult to perform as most of India lives in the villages but we have made tremendous efforts and developments in the last one and a half years in this order. We also developed two vaccines against Covid-19 which fulfils our needs and we also provided those vaccines to the world for free or at a very nominal price. This is how we are working to become *Atmanirbhar*.

The next key-speaker Prof. Madhurima Lall focused on entrepreneurship building for self-reliance and talked about her research paper on the entrepreneur industry for self-dependence. She said India has many resources whether it is natural, manpower, social, or technological but still even after 75 years of independence we are struggling to become *Atmanirbhar*. Agriculture has done well and still working tremendously. In the development process, India jumped to the

third step i.e. service sector and skipped the second step of the manufacturing economy. Here India had to work hard to join the pool of developed & self-sufficient economies. Entrepreneurship can play a vital role in being Atmanirbhar. One doesn't need to be highly educated to be an entrepreneur, he/she just needs to be highly knowledgeable about his/her work and field. The policies should be made practically acceptable and need to understand from the grass route level then only India will be able to attain the dream of *Atmanirbhar Bharat*.

The chair of the session Prof. Nar Singh emphasized the need of adding summer training projects in every curriculum to make students ready for employment and also to get them a practical understanding of the work-life.






12:30 a.m. – 1:15 p.m. Special Lecture on NEP 2020- (Meeting Room)

A special lecture on NEP 2020 was delivered (online) by Prof. Mona Khare, Head Department of Educational Finance and CPHRE, National Institute of Planning & Administration, New Delhi (online). The session was chaired by Prof. Farida Shah, former Dean, UCSSH, MLSu and co-chaired by Dr. Shashi Sanchiher, Principal. Govt. Meera Girls' College Udaipur. The other speaker (online) was Dr. Shubha Sharma, Principal Maheshwari PG Girls' College, Jaipur.

Prof. Khare deliberated on the topic "Global Education Development Agenda and NEP 2020. She elaborated on the need for the NEP from a global perspective in the context of sustainable development goals. She explained various dimensions and existing means of inclusion and employability and emphasised on provisions of NEP 2020 for strategic ways for the same. She felt the need to adopt the three-point formula to focus on more vulnerable groups, more vulnerable regions (Aspiration and SEZs) and more vulnerable facilities/activities. She also suggested creating five types of special funds to increase inclusion and employability-Horizontal equalization Funds, Special inclusion Funds, Diversity Support System Development Funds, Training and Career support Funds, and Technology Integration Funds.

The second speaker Dr, Sharma talked about the implementation aspects of NEP 2020 and the challenges in its implementation. Prof. Farida Shah concluded the session by emphasising the importance of diversity of views and freedom of speech to all in the development of education and the economy.

Issues Facing Governance in India

The plenary session on 'Issues Facing Governance in India' was chaired by Prof. M. K. Gadholiya, Vice-Chancellor, SKD University, Hanumangarh and the co-chair for the session was Dr. Deepak Sable, Mumbai. The key speaker of the session was Dr. Manohar Manoj, Managing Editor of 'Economic India' Magazine, New Delhi. Dr. Manoj initiated his lecture by defining governance and democracy. He said governance is key to all areas whether it is polity, economy, administration or society. He emphasised on corporate governance to work better in a competitive economy. He discussed in detail the governance issues in three areas – politics, public administration and the economy. According to him, we require democratic and electoral reform in politics. He said if we have to reform our Public Administration we have to be more

concerned about the productivity and efficiency of government manpower. A cost-benefit analysis should be done in public administration. On the economic front, reforms in regulatory authority are required. Private sector participation should be encouraged in the proper manner. Dr. Deepak Sable, the co-chair of the session, added that training of political leaders and minimum educational qualification is required for political reforms. He mentioned the statement of Dr. Vijay Kelkar that reforms should not be implemented in instalments and should go in one way.

Prof. Gadholiya concluded the session by pointing out that accountability, transparency and rule of law are required for good governance and the government should govern less and encourage the activities of other stakeholders.



11:45 a.m. – 01:30 p.m. Valedictory Session (Bappa Rawal Sabhaghar)

The valedictory ceremony of the 104th Annual Conference of IEA was held on December 28, 2022, at 11:45 pm. The session was chaired by Prof. Amarika Singh (online), the Hon'ble Vice-Chancellor of MLSU, Prof. Ghanshyam N Singh, Hon'ble President IEA and Prof. G.S. Rathore, Dean University College of Science. Maharaj Kumar Lakhyaraj Sing Ji Mewar was the chief guest of the ceremony and Prof. N.S. Rathore, Hon'ble Vice-Chancellor of MPUAT,

Udaipur graced the occasion with his presence as Guest of Honour. the special guest was Dr. R.K. Bhatnagar, IAS officer (Retd.), UP.

The Guard of Honour was presented to the guests and then the program began with *Saraswati Vandana* followed by *Kulgeet* of Mohanlal Sukhadia University. The fundamental duties mentioned in the Constitution of India were read by Hon'ble Vice-Chancellor Prof. Amarika Singh. Further, all the guests on the dais were felicitated with bouquets, *pagris* and *uparnas*.

The welcome address was given by Dr. D.K. Asthana, General Secretary of IEA. He welcomed the guests by introducing them to the audience. He also explained the motto of the existence of IEA and how the learning drawn from such conferences can be used for modifying the policies for rapid economic development.

Further, the report of the conference was jointly read by Dr. Neha Paliwal, Co-Organizing Secretary and Dr. M.M. Aalam from Aligarh University where they briefly presented the journey of all three days (27th December-29th December). The short descriptions of all plenary sessions, technical sessions and cultural night were given.

Dr. RK Bhatnagar discussed the impact of COVID-19 on the economy and environment and methods were discussed to deal with these serious issues. He also highlighted the challenges which usually come with the up-gradation of economic development concerning the Indian context. As per his opinion, freedom of speech is the democratic right of every citizen and should not be vested.

Prof. N.S. Rathore gave a very practical opinion on the occasion. As per his idea, an economist should be liberal and the flow of money should be there to improve the growth rate of the country. He focused on the role of agriculture in economic development. One of the biggest problem India is facing nowadays, i.e. youth inequity was stressed and solutions to solve this was asked to the audience. He also suggested that financial literacy should be introduced in the education system to teach the youth about money circulation. He inter-related GDP and agriculture and realized the significant contribution of agriculture and farmers to economic development. Further, he emphasised LIMIT (L- Loan, I-Input, M-New Market, I-Insurance, T-Technology Oriented) and explained its significance for empowering the farmers.

In the sequence, Prof. G.S. Rathore, Dean University College of Science congratulated the IEA association and organizing team for hosting the conference. He explained a general model for organizing such conferences and shared his past experiences and learning drawn from them.

Dr. AK Tomar, Chief program Coordinator OF IEA announced the best paper awards from all technical sessions. (MRS.) Asha Sablok Memorial Gold Medal for the best conference paper was given to Dr. Karimullah, Assistant Professor, University of Allahabad. The Yong Economist awards for best research papers in the teacher category were conferred to Dr. Neha Paliwal, Dr. Simmy Agrawal, Dr. Monika Varshney and Dr. Prahlad Dhakar. The best research paper awardees as Young Economist in student categories were: Ms. Jamna Kumari Rao, Mr. Hitesh Kumar Suthar, Mr. Mahipal Singh Khangaraot and Ms. Monica Bhati.

Prof. Hanuman Prasad was conferred as 'Indian Economic Association Fellow' and Prof. Nar Singh, Former Professor and Head, Department of Applied Economics, University of Allahabad was conferred with Life Time Achievement Award by Indian Economic Association.


